

Privacy Policy of the International Valuation Standards Council (IVSC)

Effective Date: 18 January 2026

This Privacy Policy explains how the International Valuation Standards Council (IVSC) collects, uses, and protects your personal data when you engage with us, such as submitting consultation responses, registering for webinars, or downloading materials from our website. By submitting your data to IVSC, you agree to the practices outlined in this policy.

1. Information We Collect

We may collect the following types of personal data:

- **Contact information:** Name, email address, and organization (if applicable).
- **Activity-related information:** Details of your participation in IVSC activities, including consultation responses, webinar registrations, and downloads.
- **Technical information:** IP address, browser type, and device information, which help us analyse website traffic and improve user experience.

2. How We Use Your Data

The personal data we collect is used for the following purposes:

- **Responding to inquiries:** To provide information or follow up on consultation submissions or webinar queries.
- **Event and registration management:** To process your registration for webinars, events, and other IVSC activities.
- **Improving our services:** To analyse how you use our website and improve the content and services we offer.
- **Communications:** To send updates, newsletters, or other relevant communications, where you have opted to receive such information.

3. Data Retention

We retain your personal data for as long as necessary to fulfil the purposes for which it was collected, or as required by law. Once no longer required, your data will be securely deleted or anonymized.

4. Data Security

We take reasonable precautions to protect your personal data from unauthorised access, use, or disclosure. However, please note that no method of data transmission over the internet is completely secure, and we cannot guarantee the absolute security of your data.

5. Data Sharing with Third Parties

We do **not** sell or rent your personal data. Your data will not be shared with third parties, except in the following cases:

- **Co-organised events or communications:** If we are co-organising an event or communication with another organisation, we may share your data with that specific organisation. This will always be clearly stated at the point of submission, and you will have the option to consent to the sharing of your data.
- **Service providers:** We may share your data with third-party service providers that assist us in carrying out specific functions, such as hosting webinars or providing technical support. These providers are required to keep your data confidential and are not allowed to use it for any other purposes.

Any sharing of data with third parties will be clearly communicated at the point of data submission, and you will have the opportunity to opt-in or opt-out.

6. Your Rights

You have the following rights regarding your personal data:

- **Access:** You can request access to the personal data we hold about you.
- **Correction:** You may request that we correct any inaccurate or incomplete data.
- **Deletion:** You may request the deletion of your data, subject to any legal or regulatory obligations we may have to retain it.
- **Opt-out:** You may choose to stop receiving communications from us at any time by following the unsubscribe link in emails or by contacting us directly.

7. International Data Transfers

As a global organisation, your personal data may be transferred to and stored in countries outside of your own. By submitting your data to IVSC, you consent to such transfers.

8. Changes to This Privacy Policy

We may update this Privacy Policy from time to time. Any changes will be posted on this page, with the updated effective date. We encourage you to review this policy periodically to stay informed about how we handle your data.
